

Regular Meeting of

Monday May 6th, 2024

A regular meeting of the Lake Preston Old City Council was held at the City Hall on Monday May 6th, 2024 at 7pm. The meeting was called to order by Mayor Wienk at 7:00 pm.

Motion by Bumann, seconded by Hope to approve the agenda. All in favor, motion carried.

Motion by Bumann, seconded by Woodcock to approve April 15th special meeting minutes with a change to remove "all in favor". All in favor, motion carried.
